- 5) I agree to indemnify and hold harmless ISMA from any claim, action, liability, loss, damage, or suit arising from their use and/or submission for competition of the material submitted, including but not limited to, copyright infringement claims.
- 6) I grant irrevocable permission to ISMA, it's agents, associates, or affiliates to use including broadcast at no fee any and all content of the musical portion of the submission on the internet, television, radio, or via any other media, outlet, or means.
- 7) I grant irrevocable permission to ISMA, it's agents, associates, or affiliates to use at no fee any image(s) or likeness(es) of the artist, band, group, ensemble, and/or any artwork representing the submission.
- 8) I grant irrevocable permission to ISMA to use the recording(s), photo(s), image(s), and likeness(es) for promotion, voting, and live broadcast during the awards show.
- 9) I understand that ISMA will not use the submission(s) for sale, resale, or any other direct financial gain.
- 10) I understand that ISMA will not release and/or share any confidential information regarding the artist(s).
